# Word from Mr. Ibrahima Coulibaly PAFO President



Farmers' Organizations call for policies that recognize and support the vital role of farming families, fostering the transmission of traditional knowledge and the preservation of agricultural diversity.

Finally, as Farmers' Organizations, we stress the crucial importance of investing in agricultural education to ensure a dynamic and well-informed next generation. Tailored educational programs, focusing on sustainability, modern agricultural management, and innovation, are essential for the future of agriculture.

These urgent calls reflect our collective determination as Farmers' Organizations to save global food systems and promote sustainable agriculture. The impact of these calls depends on the response of global actors and their commitment to a positive transformation in our way of producing and consuming food. This is an invitation to renewed collaboration with IFAD, the European Union, and the ACP countries—the opportunity to shape a future where agriculture thrives and farmers worldwide are celebrated as architects of global well-being becomes a tangible reality. It is time for action for a prosperous, sustainable, and equitable agricultural future. Farmers' Organizations stand ready to be committed partners in realizing this shared vision.





# Editorial Dr. Babafemi Oyewole PAFO CEO

The FO4 programs, namely FO4Africa Caribbean and Pacific (FO4ACP), FO4Asia (FO4A), and FO4 Latin America (FO4LA), are capacity-building programs co-financed by the European Union, the African, Caribbean and Pacific States (OACPS) and IFAD. The main objective is to increase income, improve livelihoods, ensure food and nutritional security, and enhance the security of family farming in the targeted geographical areas through greater integration of family farms into value chains. Additionally, these programs can support the development of innovation and promote strategic priorities such as environmental sustainability, gender issues, and youth within organizations. As the FO4 Programs approach their conclusion, there is a deep reflection among the stakeholders involved in their implementation.

Initiated with the aim of strengthening the capacities of Farmer Organizations, promoting rural development, and improving the living conditions of farmers, this initiative has undeniably generated significant results. Despite these successes, gaps persist and call for the continuation of the program to address them.

The evaluation of the FO4ACP Program reveals several positive aspects that have contributed to the improvement of agricultural conditions and the well-being of farmers. From institutional strengthening to the acquisition of technical skills, increased access to resources and financing, political advocacy, to knowledge and best practices exchanges, FO4ACP has significantly strengthened the capacities of farmer organizations. This has positioned them as key actors in policy development, enabling participation in policy debates and advocating for the voice of smallholders. This capacity strengthening has created a conducive political environment for sustainable and profitable agricultural activities.

While considerable progress has been made, and the results achieved so far are tangible proof of this. However, faced with the complex and evolving challenges that farmers worldwide face, it is undeniable that much remains to be done. Issues such as climate crises, land insecurity, limited market access, financial constraints, and lack of access to new technologies require sustained and strengthened attention. This is why we seek continuous and strengthened support to overcome these obstacles. We particularly encourage increased investment in strengthening the capacities of farmer organizations, with a focus on training, research and development, access to finance and markets, as well as enhancing management and leadership skills. Additionally, we call for the promotion of sustainable partnerships among the Farmer Organizations involved in the program's implementation, thereby fostering genuine knowledge and best practices exchange.

The evaluation of the FO4 programs by the Farmer Organizations demonstrates its positive impact on their organizations and the agricultural sector. However, instead of considering the end of the program as a conclusion, the stakeholders should view this stage as the beginning of a new phase, where successes can be consolidated, and future challenges addressed collaboratively for sustainability. The continuation of the FO4 Programs is not only desirable but essential. I remain convinced that our ongoing collaboration continues to make a positive difference in the lives of farmers worldwide and in the promotion of sustainable, inclusive, and prosperous agriculture in Africa.

### STRATEGY FOR FOS MAPPING



PAFO produced a strategy for mapping FOs and African agricultural local "terroir" products, focusing on promoting access to and management of farm data by FOs, and enhancing African local products with high added value. Developing a comprehensive mapping framework that covers FOs' geographical distribution and identifies African terroir agricultural products will provide a basis for informed decision-making, resource allocation, and targeted interventions. Mapping these products can also promote their recognition and valorization while preserving traditional knowledge and practices. PAFO is currently in the process of raising funds to implement the strategy.

- 17th session focused on "The potential of African regional markets: the successes of SMEs and smallholders".








### PANAFRICAN FO EXCHANGE PLATFORM


